# SHEVIOCK PARISH COUNCIL

The minutes of the meeting held on Monday 11<sup>th</sup> January 2010 in the Chapel Schoolroom, Crafthole at 7.00pm.

**PRESENT.** Councillors CK Kennedy Chairman, JM Snowling Vice Chairman, Councillors Mrs. D Mathias, P Nicholas, C Wallin P Harrison, PC Pat Libby and the Clerk DMG Dunn. There were 3 members of the public present.

### PUBLIC PARTICIPATION.

Mr. G Bracegirdle expressed his concern that only the Harbour Beach was going to have a Dog Ban and not the Finnygook Beach. He has been using the beaches for 43 years and felt that both beaches would be safer with no dogs on them during the summer.

At Seaton beach the place is full of dogs and he felt that it is unsafe for children.

He thought that the matter was to be discussed at this meeting tonight.

The Chairman informed Mr. Bracegirdle that a Dog Ban could not be enforced but a Dog Control Order is enforceable. It was decided at a Parish meeting on 23<sup>rd</sup> November 2009 that the Dog Control Order would be on the Finnygook Beach only. After distributing minutes to almost every household in the parish it was decided that due to additional information another Parish Meeting was held on 14<sup>th</sup> December 2009. At this meeting attended by 23 members of the public it was decided to have a Dog Control Order on the Harbour Beach only. Councillor Nicholas added that the Ban on both beaches was the only Bye Law left in the County.

Councillor Harrison also added that the Finnygook Beach has 4 owners and permission must be sought from all owners to have a Dog Control Order.

The Clerk was asked to reply to Mr. Bracegirdle officially.

## 2. DECLARATIONS OF INTEREST.

# 3. POLICE REPORT.

PC Libby gave his report that there had been no reported crimes committed in the parish during the last month. The speed gun training will start very shortly as soon as the last person has been approved.

The Chairman thanked PC Libby and added that it is good to see a reasonable high profile of police attendance in the parish.

# 4. RESPONSE TO PUBLIC PARTICIPATION.

# 5. MoD. TREGANTLE AND BLACKBALL BEACH.

The Chairman with Councillors Harrison and Nicholas attended a meeting at Exeter and it proved to be a useful discussion. It was demonstrated that there is a risk of 1 in 1M of bullets landing at Blackball Beach. The MoD had given the Parish Council a set of plans showing the ranges and the footprints of firing. The Chairman is due to meet the Deputy Range Warden on site on  $26^{th}$  January 2010 and will discuss signs to be erected warning the public of using Blackball Beach during live firing.

Councillor Harrison added that the area is shown on O/S maps and charts and there is a risk of ricochet.

Councillor Nicholas also added that the sign should be erected at the gate leading down to the beach.

Councillor Wallin asked for an article to be placed in the Parish Magazine explaining the situation. The

Chairman agreed to this.

## 6. PLANNING.

**KERKYRA.** 09/01943/01977/FUL. Mr. And Mrs Wilkinson, the owners, were present and Mr. Wilkinson explained with plans the application details.

**12 Burns View.** 09/01962/FUL. The Chairman declared a personal interest in that the proposed extension would overlook his property.

Councillor Mathias added that the extension would overlook the neighbouring property at 11 Burns View.

It was proposed by Councillor Mathias and seconded by Councillor Wallin not to support the application on the grounds of overlooking No 11 Burns View. Carried. The Clerk to return the appropriate form. CLERK

# 7. MINUTES OF MEETINGS HELD ON 14th December 2009.

The Chairman stated that Councillor Heapy wished for the minutes of the Parish Meeting to be changed as follows; Councillor Harrison expressed to Councillor **Heapy** expressed. After, from the parish. Add. **but does reflect their interests and therefore represents the parish views.** 

Both of these changes were proposed by Councillor Harrison and seconded by Councillor Mathias. Voting was 5 for and 1 abstention.

Councillor Nicholas wished the minutes of the Parish Council meeting also to be changed in his comments on the Parish Magazine from, **contained racist views.** To **bordering on racism.** 

After considerable discussion it was proposed by Councillor Nicholas to change the minutes accordingly. No one seconded the proposal.

The minutes of the Parish Council meeting were then proposed by Councillor Mathias and seconded by Councillor Snowling. The voting was 5 for and 1 abstention. The minutes were signed by the Chairman.

## 8. MATTERS ARISING FROM THE MINUTES.

**Asbestos in quarry.** The Chairman and Councillor Heapy had met with Paul Cressey that morning and were informed that the field adjacent to the quarry will not be planted this year and the asbestos will be removed in sealed bins, but this will necessitate the temporary closure of the adjacent footpath when the work is being carried out. The Clerk was asked to write to Mr. Cressey to verify this. **CLERK** 

**Parish Plan.** The Chairman informed the meeting that CC Trubody has been given copies of all the Parish Plans in his area and the Community Network wants to define what is still to be done on these plans. The Chairman has agreed that CC Trubody will pass copies to the Clerk to deliver to the Chairman and replies are to be returned before the end of January 2010.

There was considerable discussion over this matter and it was decided that the Clerk is to reply to Mr. Smith to the effect that the comments made were not the views of the Parish Council and that we understand Councillor Nicholas will be communicating with a separate e mail.
