## SHEVIOCK PARISH COUNCIL

The minutes of the meeting held on Monday 8<sup>th</sup> November 2010 in the Chapel School Room, Crafthole at 7.00 PM.

**PRESENT.** Councillors C K Kennedy Chairman, J M Snowling Vice Chairman, Councillors, Mr P Nicholas, Mrs Dorothee Mathias and Mr P Harrison; and Cornwall Councillor G W Trubody. There were three members of the public present.

### PUBLIC PARTICIPATION.

Public Participation was included under Agenda Item 4.

#### APOLOGIES.

None.

#### DECLARATIONS OF INTERESTS.

There were no declarations of interest on agenda items or gifts over £25.00p.

#### POLICE REPORT.

There was one crime reported in the Parish during the last month namely Theft of 10 stones from a wall at Cross Park Crafthole.

Councillor Snowling raised the recent diversion signing for work by May Gurney on behalf of Western Power Distribution for electrical work at Tredis View. PCSO Rigall agreed that it had not been satisfactory but that it was the responsibility of Cornwall Highways.

Councillor Kennedy asked PCSO Rigall to pass on the Parish Council's thanks for the introduction of the PACT web link to the Parish Council website.

#### 4. RESPONSE TO PUBLIC PARTICIPATION.

It was proposed by Councillor Dorothee Mathias, seconded by Councillor Nicholas and resolved unanimously that Standing Orders be suspended at 7.06 PM for Public Participation.

A member of the public raised various concerns regarding speeding and the use of Community Speed Watch. Councillor Mathias and PCSO Rigall responded to the points raised. PCSO Rigall also explained that Community Speed Watch cannot operate in a 40 mph area.

A member of the public asked what progress had been made with reducing the height of the Finnygook Inn fence. The Chairman stated that the matter had gone to appeal. The Inspector has stated that the fence was acceptable. Cornwall Council will have to pay the costs of the appeal.

A member of the public reported on the recent Cornwall Planning Meeting East. On the agenda was the planning application for the installation of an 11Kw Gaia wind turbine on a free standing 18m high steel mast at Higher Tredis (Application No PA10/04698). The Chairman of the Planning Committee insisted that everyone attending should wear a poppy and the consideration of the application was very unsatisfactory. The Chairman said that in future individuals will have to write to Cornwall Council with comments on any planning application for the Parish that was being considered by the Cornwall East Planning Committee.

It was proposed by Councillor Snowling, seconded by Councillor Nicholas and resolved unanimously that Standing Orders be re-instated at 7.16 PM ending Public Participation.

## 5. PLANNING.

Construction of conservatory to incorporate replacement roof to existing outbuilding - Mr Wilkinson - PA10/06645 Crukies Corner Sheviock Torpoint Cornwall PL11 3EN.

The Parish Council had supported this application.

East Car Park Finnygook Lane Portwrinkle Torpoint Cornwall PL11 3BT Replacement and repositioning of cafe/kiosk (amendment to approved scheme E2/10/00754/FUL) - Mr A Collins - PA10/06505.

The Parish Council had supported this application.

There have been instances of planning applications in adjacent parishes bordering on Sheviock Parish, often with implications for the Parish. It was agreed that this matter would be raised at the next Cornwall Gateway Network Operations meeting.

CHAIRMAN

Councillor Mathias had also attended the recent Cornwall Planning Meeting East which considered the planning application for the installation of an 11Kw Gaia wind turbine on a free standing 18m high steel mast at Higher Tredis (Application No PA10/04698). She stated that the Chairman had "used bullying tactics and shown disrespect for members of the public." Councillor Mathias presented the Parish Council's views. She gained the impression that "the result was a foregone conclusion." Councillors did not declare receipt of a CD from the applicant, provided to them on the previous evening, if they had viewed it or knew who had sent it. Councillors expressed disquiet at the the conduct of the Chairman and the procedures of the Planning Committee

Councillors expressed disquiet at the the conduct of the Chairman and the procedures of the Planning Committee including the information reported from the Parish Council.

It was proposed by Councillor Harrison, seconded by Councillor Mathias and carried unanimously that the conduct of the Chairman of the Committee should be referred to the Cornwall Standards Board. CLERK It was proposed by Councillor Nicholas, seconded by Councillor Harrison and carried unanimously that the irregularities in procedure of the Committee be referred to the Corporate Director for Environment, Planning and the Economy.
